#### 2019 LOW TO MODERATE INCOME SENIOR CITZENS DISCOUNT

#### **GUDELINES**

- 1. This discount will be for a House Holder (as defined in the dictionary as being the head of the family one who owns or rents a home).
- 2. The age requirement is 65 years of age or older.
- 3. The annual income scale for all applicants shall be as follows.

a.	1 person living in the home	\$21,500.00
b.	2 persons living in the home	\$24,600.00
c.	3 persons living in the home	\$27,650.00
d.	4 persons living in the home	\$30,700.00
e.	5 persons living in the home	\$33,200.00
f.	6 persons living in the home	\$35,600.00
g.	7 persons living in the home	\$38,100.00
h.	8 persons living in the home	\$40,550.00

- 4. All applicants must complete a
  - a. Written notarized application.
  - b. Show proof of age.
    - Driver's license
    - Birth Certificate
  - c. Show proof of established household

- d. Show proof of income, this will be verified before the credit is given.
- e. Sign the application agreement, agreeing to abide by the terms and conditions or the agreement.

#### 2019 LOW TO MODERATE INCOME SENIOR CITZENS DISCOUNT

#### **TERMS AND CONDITIONS**

- 1. The Low to Moderate Income Senior Citizen Discount will be applied to a monthly usage of 300 cubic feet or less. If your usage is more than 300 cubic feet, you will be billed at the current existing rate.
- 2. If the applicant exceeds the maximum monthly consumption of 300 cubic feet ,more than 3 times in a calendar year the City Division of Finance, Utility Billing reserves the right to reevaluate the terms of the agreement and possibly cancel the benefit.
- 3. This benefit is non-transferrable from one house holder to another, except in the case of that a surviving spouse becomes the head of house hold.
- 4. The City Division of Finance, Utility Billing office reserves the right to request updated proof of income at any time.
- 5. The discount only applies to the Water & Sewer portion of

• Current year Income Tax Return and year end Social Security Statement

If No Income Tax Return is filed we will accept the following as proof of Income:

- 1. All W-2's
- 2. Year end Interest Statements (1099INT)
- 3. Yearend Ordinary Dividends Statement (1099DIV)
- 4. Taxable Refunds from State or Local Government (1099G)
- 5. Year end statement proof of Alimony received
- 6. Year end Business Income Statement (1099MISC)
- 7. Year end Capital Gains Statement (1099B)
- 8. Year end Statements for IRA's, Pensions, & Annuities (1099R)
- 9. Rental Income
- 10.Farm Income
- 11. Year end Unemployment Compensation Statement
- 12. Year end Social Security Benefit Statement
- 13. Other Income (Lottery, Gambling Winnings, Etc...)

Please Note: Total annual income is determined per household, and not per individual. The low to moderate senior citizen discount is only available to qualifying residents who receive water bills from the City of Ashland Division of Finance, Utility Billing office.
